Brief facts of the case

Mr. Steive Enderson, Reg No: 435003 completed BA English course in 20010 from Yerwada University, yet have not received original degree certificate.

Reason/Ground for appeal

Question Number 3, 4, 5 answers given by the State Information Officer is incorrect and unsatisfactory on the grounds of section 19(1), (3) of RTI act 2005. It is clear that information supplied by the authority is against the above rules and legal regulations prescribed in the mandate. For this cause I would like to request you to provide information(s) against question number 3, 4, 5 to deliver justice.

Brief facts of the case

The petitioner has completed BA English course in 2010 from Yerwada University, Reg.No: 65703, applied for final certificate in 2011, yet not received original degree certificate. The petitioner has visited Yerwada University several times and inquired to concerned authorities but he has not given any prompt reply.

Reason/Ground for appeal

1. That, the petitioner has lost hope to get certificate from the concerned

authority, those who are responsible to issue the same on time. As this reason petitioner filed an RTI application before the State Information Officer of the Yerwada on 19/05/2015, but the answers of question number 3, 4, 5 are falsified and denied to give documents which the petitioner asked for. Answer of question number 2 is wrong on the grounds of provisional certificates validity will expire after 6 months of issue.

2. To get justice, petitioner had moved before FAA, but he exercised his authority to deny justice and prescribed about final certificate issuance, rather delivering documents, therefore the petitioner suspects that the action performed by him was mysterious and tried to pacify fundamental right of a person to protect lawbreakers.
3. That the SPIO and FAA's are holding higher level positions as they are aware of RTI law and accountable to deliver justice and obey law. Here, it not the first time Yerwada University SPIO exercised his authority on providing wrong information. On 26/Oct/2010 the petitioner filed an RTI application for information regarding the status of Reg.No:45664 revaluation process but information given by SPIO mentioned that the revaluation application has been rejected due to the delayed submission of application, to avail immediate justice the petitioner forced to file an appeal before Hon'ble High Court of Karnataka. This seems that there is a collective effort being played to avoid law and their answerability.
4. Due to above facts, the petitioner was very aggrieved from the decision of First Appeal Authority that the petitioner stands on very firm legal ground to submit his complainant before the Hon'ble court of the State information Commissioner to deliver justice and reinstate fundamental rights and belief in RTI act 2005.

It is, therefore, respectfully prayed that this Hon'ble Court may kindly be pleased to:-

1. Direct opposite party to issue documents which the petitioner asked for.
2. Impose maximum fine prescribed in the mandate.
3. Recommend disciplinary action against opposite party to place as a sign board to those who intend to disrespect law and disrupt Constitutional rights.

I will like to be personally present through video/audio conferencing after getting Notice of hearing from you.
